Re: The Need for a Substantial Salary Increase for Federal Judges

Dear Chairman Conyers and Ranking Member Smith:

The Association of Corporate Counsel (ACC)¹, the bar association for lawyers employed as in-house counsel in companies, respectfully encourages you to support legislation that would substantially increase the pay of our federal judiciary.

You have already heard from a broad spectrum of the business and legal community – corporations, business groups, bar and other legal organizations, and law-school deans and professors – in support of a substantial salary increase for federal judges. This increase also is vigorously endorsed by the Chief Justice of the United States and the Administrative Office of the United States Courts. ACC will not repeat their submissions, but we join in their views and believe they have made a compelling case for such an increase by any standard – whether judicial pay measured in real (inflation-adjusted) dollars, in relation to wage increases for senior federal Executive Branch officials and American workers in general, or in comparison to the higher salaries paid to other practicing lawyers in the profession (from entry-level associates in big firms to law-school deans). Reasonable compensation is an integral part of the country's fair bargain with the federal judiciary and is necessary to furthering the constitutional design expressed in Article III of judges who serve for life. As Chief Justice Roberts recently explained, “[i]nadequate compensation directly threatens the viability of life tenure.” 2006 YEAR-END REPORT ON THE FEDERAL JUDICIARY 6 (Jan. 1, 2007). Only appropriate pay levels will enable the federal bench to continue to attract and retain the very best of the legal profession from all backgrounds and economic situations.
